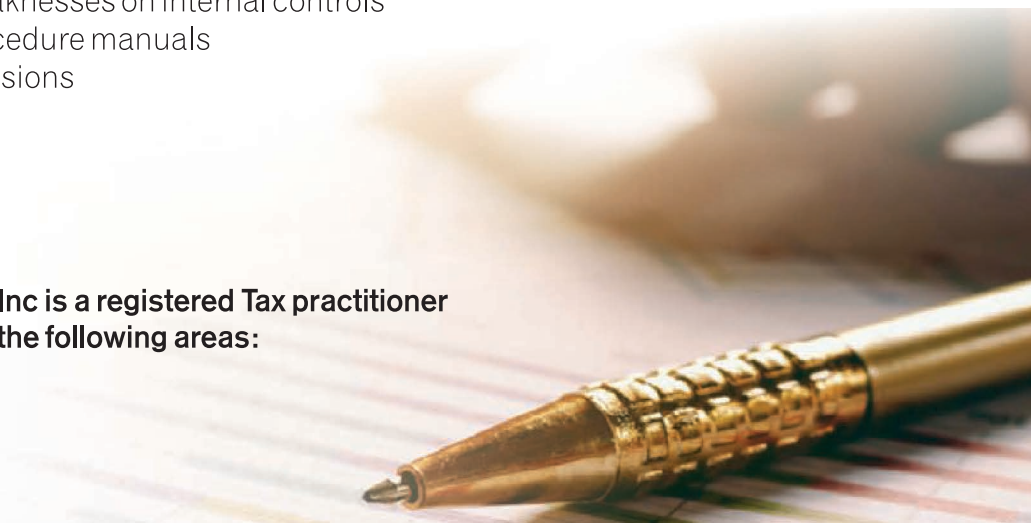

DID YOU KNOW?

- You need not submit an Income Tax Return if you receive an annual turnover of less than R500,000.00
- The use of the Tax Clearance Certificate (TCC) will be replaced by the Tax Compliance System (TCS)
- Each registered company must submit Annual Returns to CIPC (annually)
- When your revenue exceeds R 1 million in a period of 12 months you must register for Value Added Tax (VAT)
- When your payroll exceeds R 500,000.00 in a period of 12 months you must register for Skills Development Levy (SDL)
